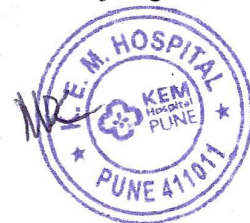

Memorandum of Understanding

This Memorandum of Understanding ("MOU") is made and executed at Pune on this 5th day of January 2023.

Between

Siddh Divyang Foundation a company registered as a Section 8 Company under the provisions of the Companies Act, 2013 (18 of 2013), having the registered office at Yashodham Building, 440/7 Gokhale Cross Road, Shivajinagar, Pune,



Maharashtra - 411016, India bearing PAN no. ABGCS1733G represented through Mr. Uday M. Mehta, Founding Director, hereinafter referred to as the 'SDF' which expression shall, unless repugnant to the context thereof, mean and include its successors and assigns

And

KEM Hospital, Pune, a society registered under the Societies Registration Act, 1860 vide registration no. 710/PUNE and a charitable trust incorporated and registered under the provision of Bombay Public Charitable Trust Act 1950 bearing Reg.No.F/61/P(Pune), having its registered office at 489, Rasta Peth, Sardar Moodliar Road, Pune, Maharashtra- 411011, bearing PAN No. AAATK8155E, represented through Dr. Madhur Rao, Senior Deputy Medical Administrator, hereinafter referred to as the 'KEM' which expression shall, unless repugnant to the context thereof, mean and include its Trustees, administrators, successors and assigns

In this MOU, SDF and KEM are hereinafter individually referred to as a "**Party**" and collectively referred to as the "**Parties**".

Whereas

SDF is a non-profit and charitable company founded in the year 2021 engaged in the development and implementation of assistive technology-based solution for the empowerment of Divyang children living in the tier 1 cities to tier 5 villages of India which is being given to the beneficiaries at no cost to them through projects mainly in following domains.

1. Education for Divyang Children
2. Livelihood for Divyang Children and persons

KEM is a 550+ bedded multi-specialty teaching hospital. KEM is a Centre of Excellence especially in Critical Care, Diabetology, Nephrology and Dialysis, High Risk Obstetrics, Neonatology and a comprehensive Rehabilitation Centre for children with special needs.

The Paediatric Department at KEM was established in the year 1979 with the aid of a German Social Service Organisation – **Terre Des Hommes Rehabilitation and Morris Child Development Centre** ("TDH") referred to as KEM-TDH. This was the first such centre in India for the comprehensive diagnosis and therapy of children with all manner of physical and mental challenges.
